## AmigaDE PPC Community Terms Of Use

### §1 Content copyright

The AmigaDE PPC Community (ADEC) contains Files and Data of both open source and proprietary nature. The Files and Data you get access to within the ADEC may be copied and/or spread as a general rule without prior written permission from Genesi Luxembourg S.à.r.l (Genesi) but in accordance to the license included. Files or Data marked as "Proprietary" are the sole property of Genesi and may not be copied or spread in any way without prior written permission from Genesi. Licensors may elect to use the Genesi Luxembourg S.à.r.l Public License as an Open Source community License for their Software. Logos, Copyrighted material and Trademarks presented on this site may not be copied, except if the relevant property holder has expressly granted permission. Forum entries on public, open Forums may be quoted or copied outside of this website but may not be quoted if they are put forward in an "Proprietary" Forum, unless you are the sole author of the entry you quote or you have obtained a written permission from Genesi. Program code extracts (snippets) posted on Forums or otherwise, are to be treated as the licensed module as such, if no specific term is included, according to the provisions the relevant license dictates. Derivative works, including minor derivative works such as patches, are to be governed by and licensed according to the License associated with the Software they derive from/are relevant to, unless otherwise specified in the relevant license. ### §2 Description of service

Unless explicitly stated otherwise, any new features that augment or enhance the current Service, including the release of new ADEC properties, shall be subject to the Terms of Use (TOU). You understand and agree that the Service is provided "AS-IS" and that Genesi, or any of its group companies or affiliates, assumes no responsibility for the timeliness, deletion, miss delivery or failure to store any user communications or personalization settings. You are responsible for obtaining access to the Service and that access may involve third party fees (such as Internet service provider or airtime charges). You are responsible for those fees. ### §3 Confidentiality
